# MINNESOTA INTERAGENCY COUNCIL ON HOMELESSNESS (MICH)

Minnesota Interagency Council on Homelessness (MICH) is a cabinet-level body led by Lt. Governor Flanagan. It comprises the commissioners of 14 state agencies and the Chair of the Metropolitan Council. It is accountable for leading the state's efforts toward housing, health, and racial justice for people experiencing homelessness and committed to using the strategic plan to guide the work of state government on homelessness through 2027. mich.mn.gov

### CROSSROADS TO JUSTICE STRATEGIC PLAN

Crossroads to Justice: Minnesota's New Pathways to Housing, Racial and Health Justice for People Facing Homelessness, is the State of Minnesota's strategic plan to prevent and end homelessness. The plan is the culmination of a year-and-a-half-long process that was co-led by 10 paid Justice Consultants, all people with lived experience of homelessness representing different experiences and different parts of the state. In 2022, after the shared experience of working with partners across Minnesota to protect and support people facing homelessness during the pandemic, while confronting the racism and injustice in our systems following the murder of George Floyd, Governor Walz and Lieutenant Governor Flanagan tasked the Minnesota Interagency Council on Homelessness with developing a strategic plan focused on justice.

## ROLE OF RAINBOW RESEARCH, INC

The State contracted with Rainbow Research, Inc. to complete Phase 1 and Phase 2 and is currently active in Phase 3 to provide ongoing support and engagement of Implementation Consultants with lived experience of homelessness. The consultants represent different experiences and different parts of Minnesota in their work to co-implement the Crossroads to Justice Strategic Plan.



#### IMPLEMENTATION CONSULTANTS

The Crossroads to Justice Strategic Plan is being coimplemented with 14 paid Implementation Consultants, all people with lived experience of homelessness representing different experiences and different parts of the state.


