The organization provided training and technical assistance to staff at all levels, enabling clients to independently collect, analyze, and use data to drive continuous learning and program improvement. This work advanced systems-level change by equipping partners to identify structural barriers, assess service delivery, and use evidence to inform strategies that improve equity, coordination, and long-term outcomes for the communities they serve. Capacity-building services engaged 50 organizations and 5,000 people. In addition, numerous initiatives
